Abstract: The Newtown Oral History Collection consists of oral histories created by residents and former residents of Montgomery, Alabama's Newtown neighborhood.

Languages and Scripts: The entire collection is recorded in English.

Administrative/Biographical History: Foster Dickson was born on August 23, 1974. Dickson earned his bachelor's degree in English in 1996 and master's degree with an emphasis in English in 2008 at Auburn University at Montgomery. Since 2003, Dickson has taught Creative Writing at Booker T. Washington Magnet School in Montgomery, Alabama, where his teaching won him the 2009-2010 Secondary Teacher of the Year by the Parent Teacher Association of Alabama. In addition to teaching, Dickson is the author of *Closed Ranks: The Whitehurst Case in Post-Civil Rights Montgomery* and editor of *Children of the Changing South*.

Scope and Content: The Newtown Oral History Collection is a collection of oral histories and photographs created at the Newtown Community Center on February 23, 2019. The oral histories center on daily life in Newtown throughout the 1950s and into the 1970s. The oral histories in this collection represent how the creators of the collection, those that live or lived in Newtown, view their community and constitute a valuable primary source regarding first-person observations and opinions regarding the Civil Rights Movement. A number of the oral histories in the collection dwell on similar themes, including civil rights, the Civil Rights Movement and how it affected the city. Many of the interviewees also talked about a devastating flood in 1960

that destroyed almost all their possessions. The photographs depict the interviewees, as well as the event itself.

System of Arrangement: This collection is organized into two series:

Series I: Oral Histories

This series contains ten oral histories created by current and former residents of Newtown. Although the oral histories range far in terms of the time frames discussed, many center on 1950-1970.

Series II: Photographs

This series contains thirty photographs taken on the same day that the interviewees created the oral histories in the collection. The photographs depict the interviewees, as well as the event itself.
